Placement in class depends on age: Preschool—age 3 by August 31, 2025; Pre-Kindergarten—age 4 by August 31, 2025.

All birthday exceptions must be approved by the preschool director. Child must be fully toilet trained before entering preschool.

<u>New Student Application Fee</u>. This **non-refundable** fee is required for all new students and pays for processing a student's application to Bellevue Christian School (BCS). The fee is paid online when making application.

Enrollment/Re-enrollment Fee. Payment of the enrollment/re-enrollment fee is an acceptance of Bellevue Christian School's offer to enroll/re-enroll and is confirmation the enrolled/re-enrolled student will attend Bellevue Christian. The fee is due upon enrollment/re-enrollment and non-refundable once billed or paid no matter when the student is enrolled. The enrollment/re-enrollment fee is not a deposit on, nor a prepayment of, tuition. Returning families must clear their account balance to be eligible for re-enrollment.

<u>Annual Tuition</u>. Bellevue Christian charges annual tuition due May 1. Payment plans are offered as an alternative to making payment in full. All payment plans are governed by BCS tuition payment and withdrawal policy, outlined below, and the enrollment contract.

- One-Pay A: paid in full by May 1, 2025, with a 2% discount. Option to pay by BCS-managed ACH with prior arrangement, bank bill payment, or through Veracross portal (VC Pay). Discount expires May 2. VC Pay convenience fees apply.
- One-Pay B: paid in full by May 1, 2025, by wire or Flywire (this option is for payers with international funds). Does not receive 2% discount.
- Ten-Pay: paid in 10 monthly installments beginning May 1, 2025, and ending February 1, 2026, by BCS-managed ACH, bank bill payment, or VC Pay. Does not receive 2% discount. VC Pay convenience fees apply.

NOTE: tuition assistance is not available for Preschool and Pre-Kindergarten tuition and fees.

Other Preschool and Pre-kindergarten Fees. Fees for field trips may be charged.

Payment Terms

- Payments are due by the 1st of the month; payments via ACH will occur on the 5th of the month.
- Account balances that are paid by the 5th of the month will avoid late fees.
- All unpaid accounts will be subject to monthly late fees totaling \$65.
- Any check or ACH that is returned for any reason will be subject to a \$25 return fee (check/bank bill payment/ACH) or \$15 return fee (VC Pay).
- Bank and card payments made through VC Pay will be subject to convenience fee.
- Students may not attend classes or participate in any school activities beginning the first day of the following month, if the previous month's balance is not paid.

<u>Force Majeure</u>. In the event of school closure beyond the school's control, the School's duties and obligations will be postponed until such time as the School, in its sole discretion, may safely reopen and/or comply with its duties and obligations. A full description is provided in the online enrollment process.

<u>Separation from School; Payment Policy</u>. If a student withdraws after they have enrolled, any tuition and fees accrued through the end of the month of withdrawal are due regardless of the date. Tuition will be calculated based on a 10 month installment plan beginning May 1, 2025. Refunds only for payments made over and above tuition and fees charged through the month of withdrawal. Tuition responsibility is as follows:
