**Enrollment/Re-enrollment Fee.** Payment of the enrollment/re-enrollment fee is an acceptance of Bellevue Christian School's offer to enroll/re-enroll and is confirmation the enrolled/re-enrolled student will attend Bellevue Christian. The fee is due upon enrollment/re-enrollment and **non-refundable** once billed or paid no matter when the student is enrolled. The enrollment/re-enrollment fee is not a deposit on, nor a prepayment of, tuition.

**Priority Re-Enrollment.** Open only to current BCS students re-enrolling for the 2026-2027 school year. Tuition accounts must be current. Open enrollment begins January 30 for all new families wishing to enroll in BCS. Returning students not re-enrolled by January 31 may be waitlisted; students re-enrolling after January 31 pay the open enrollment fee.

**Required annual I-20 Service Fee** for the maintenance of Form I-20 for any student attending on F-1 visa. The I-20 Service Fee is not a deposit on tuition. Service fee is charged annually, paid with enrollment or re-enrollment. The I-20 Service Fee is **non-refundable** except for F-1 visa denial prior to May 1.

**Deposit for Student Expenses** during the school year. **Required** for any student attending BCS on any visa. (Elementary expense deposit is waived if elementary student has a sibling in grades 7-12 attending on any visa.) Expense deposit is replenished each year. Expense deposit remaining in tuition account after paying all fees or tuition is refunded at graduation or withdrawal. **NOTE:** Transportation fee, insurance, and textbooks are not covered by the expense deposit. (See fees, page 2.)

**Annual Tuition.** Annual tuition is due May 1. Payment plans are offered as an alternative to making payment in full. All payment plans are governed by the applicable BCS tuition payment and withdrawal policy, outlined on Page 2 of this schedule, and the enrollment contract.

**Payment plans for any student with US citizenship or green card**

- One-Pay A: paid in full by May 1, 2026, with a 2% discount, by BCS-managed ACH with prior arrangement, bank bill payment, or through Veracross portal (VC Pay). **Discount expires May 2.** VC Pay convenience fees apply.
- Ten-Pay: paid in 10 monthly installments beginning May 1, 2026, and ending February 1, 2027, by BCS-managed ACH, bank bill payment, or VC Pay. Does not receive 2% discount. VC Pay convenience fees apply.

**Payment plans for any student attending on any visa**

- One-Pay A: paid in full by May 1, 2026, with a 2% discount. As described above. US bank accounts only for ACH and bank payments.
- One-Pay B: paid in full by May 1, 2026, by wire or Flywire (this option is for payers with international funds). Does not receive 2% discount.
- Two-Pay: Installment 1 is due on or before May 1, 2026, paying 60% of annual tuition; Installment 2 is due on or before September 1, 2026, paying 40% of annual tuition. Does not receive 2% discount. Pay by check, bank bill pay, BCS-managed ACH, wire, Flywire, or VC Pay. VC Pay convenience fees apply.

**ELL Tuition.** Participation in ELL is required for students with a TOEFL score of less than 92, regardless of visa or Green Card status. The annual ELL tuition is non-refundable once billed or paid. The student will receive ELL support for the entire school year. If a student participating in ELL withdraws after they have enrolled, the Separation from School Payment Policy for Any Student Attending on Any Visa will apply. (See Page 2.)

**Student Academic Services (SAS) Program.** Please see the separate Student Academic Services Tuition Schedule for 2026-2027 for full program tuition.

**Tuition Assistance.** For qualifying families for students in Kindergarten through 12th grade. Annual application required. No 2% discount if tuition paid in full. Assistance not available for student attending BCS on any type of visa.

## Payment Terms

- Payments are due by the 1st of the month; payments via BCS-managed ACH will occur on the 5th of the month.
- Account balances that are paid by the 5th of the month will avoid late fees.
- All unpaid accounts will be subject to monthly late fees totaling \$65.
- Any payment that is returned for any reason will be subject to a \$25 return fee (check/bank bill payment/ACH) or \$15 return fee (VC Pay).
- Bank and card payments made through VC Pay will be subject to convenience fees.
- Students may not attend classes or participate in co-curricular activities beginning the first day of the following month if the previous month's balance is unpaid.

## Separation from School; Payment Policy

**Separation from School; Payment Policy.** If a student withdraws after they have enrolled, tuition and fees accrued based on the applicable withdrawal chart below are due regardless of the date of actual withdrawal.

Refunds only for payments made over and above tuition and fee responsibility. Tuition responsibility is as follows:

**Bus Transportation:** Can be paid in full or by installment, starting as early as May 1. International families who wish their student to ride the bus should pay the fee with the May 1 **tuition** payment. Arrange with Student Billing. Refundable prior to September 15, 2026. See Transportation Agreement in online enrollment and on parent portal for more details.

**ISP Support Fee.** The International Student Program provides support (“ISP Support”) to international and domestic students regardless of visa status. ISP Support includes, but is not limited to, teacher-student liaison, translation assistance, mentoring, community services and connections. ISP Support Fee is an annual fee; support is provided for the entire school year for which fee is paid. The ISP Support is provided, and the ISP Support Fee, is charged at the sole discretion of Bellevue Christian School.

**JH/SH Textbooks/Workbooks.** Most textbooks are purchased by family after student schedules are published in summer. At that time, required textbooks lists are made available on the parent portal. BCS purchases and delivers to the student *some* required workbooks and textbooks as identified in course catalog and/or the required textbooks lists; family invoice is charged.

**JH/SH Grade-level or Class-specific Events & Retreats:** Required participation in grade-level or class-specific events or retreats. Fee varies. Event or retreat will be communicated in advance. Fee is not refundable after billing date.
